1. Call meeting to order

Chairman Steve House called the meeting to order at 7 p.m.

2. Consideration of May 12, 2008 minutes

3. Doug Fitts and Bret Benway (Ice Pond Corp.) - Final Plan Review for Clark's Point Subdivision, 34 dwelling units, roads and fire pond, Map R-5, Lot 122

Doug Fitts said he had complied with the Planning Board's request to add to the plan the location of the pond, true north arrow, surveyor's stamp, right of way and curve data, and the language for conditions of approval.

Town Planner Jeffrey Hinderliter recommended that the application be considered as a traditional subdivision, not a cluster subdivision, and that the State Subdivision Review Criteria be approved by reference. Note 6 on the plan referring to cluster subdivision will be deleted. He submitted the following comments to the Board on the review criteria:

No. 6: Part of the exception request (note 10 on plan), conditions 1 and 4 and written response included with the packet given to the Board

No. 10: Pond was approved by DEP during January 2008.

No. 12: Part of exception request (note 10 on plan), conditions 3 and 4.

No. 13: Technical is acceptable, should written evidence of line of credit be required?

No. 18: Erosion control information located on plans and written documentation provided in response to review criteria.

Nos. 20 and 21: Part of exception request (note 10 on plan), conditions 1 and 4 and written response included in packet given to the Board.

No. 22: See condition 3.

No. 24: See above comments concerning cluster subdivisions.

Fitts will provide a letter of credit for the file. In addition to the four conditions for approval, which Jeffrey had recommended at the previous meeting (having a professional engineer inspect the streets during construction, obtaining applicable DEP approvals before construction, submitting final condominium documents before sale of first unit and stating that roads will not be reduced to 16 feet if there is no ordinance change), a fifth was added requiring Planning Board review and approval of any changes in building footprints and locations before construction.
