# 4. Ames Supply - Final Site Plan Review for 14,500 sq. ft. building addition, 447 Bath Road, Map U-14, Lot 6

The applicant has received a verbal okay from DEP and is waiting for a letter to that effect. Kevin Clark, Sitelines, said the project had received approval from the DOT less than five years ago and he asked for a waiver from the board on submission of the DOT approval. He said a traffic count was not required and only the site of the curb cut needed confirmation.
