 - 1. Next Master Plan meeting slated for October/November. Stantec needs input from town concerning desired airside and landside improvements.
 - 2. Fence/Gate Project Sections of fence and gates installed on west end of airport. Contractor has order gate control units for remaining sections and will install when received. Anticipate early October.
- F. Miscellaneous
 - 1. Maintenance hangar door safety cable failed and the door closed without warning. Ken returned it to service. The door needs a new drive system; one that will prevent the door from closing with force. Erv will look into a new system.
 - 2. Mid-Coast Air & Land Family Festival and Air Show scheduled for October 1. Planning committee meeting on regular basis.
 - 3. Maine DOT is scheduling ACIP meetings. Committee approved Erv to attend and address our capital plans (see attached).
 - 4. Kevin Sprague, resident of Wiscasset, has volunteered to be the committee's fifth member. Committee members talked to Kevin and voted 4-0 to recommend his appointment. Erv



will provide Kevin with necessary paperwork and have his name placed on the Selectman's agenda.

5. FBO Lease Agreement. Lease discussions and negotiations still underway with Ocean Point Aviation. Erv and David Stapp have met several times and agreed to wait until after the summer flying season to address details.
