Ken Boudin, Chair, called the meeting to order at 6:00 pm

A. Minutes from May 10, 2013 meeting were read and approved (5-0)

#### B. Manager's Report

#### 1. Budget

- Current (Through May 30, 2013): 92% of the fiscal year, 93% of expenses have been expended and revenue is at 97%.
- FY 2014 (July 1, 2013 June 30, 2014. Voters approved the budget. Expenses of \$298, 000 and Revenue of \$315,800 (rounded).
- 2. Wings Over Wiscasset. Manager briefed the committee on the WOW event, scheduled for August 6.

#### 3. FBO Operations

- a. Staffing FBO open 5 days per week until July 1. Winston (Greg) Smiddy hired as Kim's assistant.
- b. Fuel sales for fiscal year through May 30:

#### 4. Project Status Updates

- a. Environmental Assessment. Ken worked with the town manager, Stantec, FAA and MaineDOT in finalizing the scope of work and fee for the project. The next step will be to submit a grant application to the two funding agencies.
- b. Master Plan. Committee not happy with the time it's taking to get the master plan finalized. Instructed airport manager to "get it done!"

#### C. Old Business

- 1. Crosswinds Maintenance lease was officially terminated. Lessee to vacate building by June 30, 2013.
- 2. A&P Request for Proposals advertised.
- 3. Previous tax lien on hangar owner lifted (back taxes paid in full).

#### D. New Business

1. Hangar and based aircraft owner Nick Knobil would like to disassemble old airport beacon and refurbish the lens section as a display. He proposes creating two separate wall mounted units, one for his hangar and one for the airport. The Committee approved and recommends a 99 year lease at no cost. Manager will prepare said document for signature.
