Chair Judy Colby called the meeting to order at 6 p.m.

- 1. Pledge of Allegiance
- 2. Approval of Treasurer's Warrants
- a. Kathy Martin-Savage moved to approve the payroll warrants of September 8 and 15, 2017. Vote 5-0-0.
- b. Kathy Martin-Savage moved to approve the accounts payable warrants of September 12 and 19, 2017. Vote 5-0-0.
- 3. Approval of Minutes

Ben Rines, Jr., moved to approve the minutes of September 5 and 12, 2017. Vote 5-0-0.

- 4. Special Presentations or Awards: none
- 5. Committee Appointments
- a. Jeff Slack moved to appoint Shaye Paradis to the Budget Committee. Vote 5-0-0.
- 6. Public Hearing none
- 7. Public Comment

Steve Christianson inquired about the removal of the Hesper sign at the waterfront, which he said was supposed to take place by Labor Day. Town Manager Marian Anderson will look into the matter.

Dick Forrest said the Waterfront Committee's role is advisory, not enforcement; however, he had noticed some violations at the pier, and it was unclear who was enforcing pier policies. He was advised to notify the Town Manager who would delegate responsibility for correcting the violation to the appropriate party.

- 8. Department Head or Committee Chair
- a. Fire Chief T. J. Merry
  - Repairs to Engine 6: Merry said the bill for repairs to Engine 6 was more than half of his fleet budget for the year, and he will be over budget. The annual pump test at \$375 will be required for each truck; chassis inspections for all four trucks will be necessary. Public Works

Director Doug Fowler said that he is looking into the acquisition of equipment for the garage to certify and license town vehicles.

- In response to a question on filling fire extinguishers, Merry said he rarely does that because they have to be sent out six at a time, and he advised that disposable extinguishers be bought at Ames instead.
- b. Police Chief Jeffrey Lange Request to purchase ID card maker: Lange said the ID card maker would allow the Police Department to issue Carry Concealed Weapons permits with photo ID attached, and all Town Employees could have photo IDs. Funds received for conducting background checks on applicants for Carry Concealed Weapons permits could be used toward the purchase of the ID card maker as well as contributions from other departments. Cost of the equipment is \$3,213. Marian Anderson recommended getting quotes from other companies. Ben Rines, Jr., and Jeff Slack recommended considering purchase of the equipment in next year's budget. In response to Ben Rines' question, Lange said photo IDs are not required for CCWs. In response to a comment that department heads seemed to come up with unbudgeted funds for new equipment or other items, Police Chief Lange and the EMS Director Martin explained that they had worked extra hours without pay in order to offset the cost of needed equipment.
- c. Department Head Monthly Reports: In response to Jeff Slack's question, Martin said the majority of calls from Dresden have traditionally been in the winter months and average 113 per year. Income from Dresden calls will be generating \$30-40,000 per year plus the annual subsidy.

Marian Anderson said, in response to a previous question, the Treasurer's monthly report includes bank balances for Town, the schools and the elementary school.

### 9. Unfinished Business

- a. Balzer Clock Works Town Clock: Rick Balzer, whose company services the 1907 E. Howard round clock in a building on Fort Hill Street, reported to the board on the condition of the clock and tower and recommended removing the clock from the steeple, repairing it, and installing it in a town-owned building where it can be displayed. He said current access to service the clock monthly is difficult, as the Town does not own the building where the clock is located and the tower is in poor condition. The clock and tower were given to the Town in 1907 by William Henry Clark. The deed to the clock and tower will be researched and it was suggested that members of the board inspect the tower and clock.
- <u>b. 2017-2018 Tax Commitment</u>: The board decided at the previous meeting to take \$619,000 out of the fund balance which would result in a mill rate of \$18.76, a less than .5% increase. **Ben Rines, Jr., moved to set the 2017-2018 mill rate at \$18.76 and sign the commitment paperwork. Vote 5-0-0.**
- c. Discussion of Public Safety Council's letter: Marian Anderson said information for a formal response to the council's letter was being compiled. She said the new mechanic had computerized record-keeping which will help in generating information in the future.
- d. Discussion on Budget Reduction for FY 2018-2019: Marian Anderson said she and Fred Quivey of the Budget Committee had discussed the request by the board to reduce next year's budget by \$500,000, or 10%. She distributed a draft matrix, indicating which budgets were under control of the select board and which parts are not, such as public utilities and unemployment insurance. She asked the board how

flexible it wanted to be in attaining the goal of reducing a half million from a 5 million dollar budget. Fred Quivey added that the board has control over only 41% of the budget, the school department making up the balance, or 59% of the budget. Revenue brought in by the various departments, offsetting the budget amounts can be added to the matrix. It was suggested that the assessor be asked to provide his numbers in August.

### 10. New Business

a. New England Clean Energy Connect presentation – John Carroll, CMP: Carroll said that in an effort to diversify energy resources in New England, Massachusetts has issued an RFP to private utilities for a multi-million dollar regional competition to develop the next phase of clean energy projects in New England. Central Maine Power Co has submitted a plan to build a high-voltage transmission line through western Maine to bring hydroelectricity from Quebec to Massachusetts. He described the possible corridors running from a new substation in Lewiston to Quebec. The project would require a new line to Maine Yankee. There will be no change to the line for the first three miles from Maine Yankee. He said the project would result in a reduction of CO<sub>2</sub>, suppression of energy prices across New England, the addition of 1700 jobs and an annual tax benefit to Maine of \$18 million. He asked for support from the community and will send a draft letter of support for the board's consideration.

### b. Monthly Financials

- Department year-to-date expense report: Most of the budgets are on target. The auditor will give a report to the Selectmen on November 7.
- H.M. Payson Account Statement: Anderson reminded the board that the Investment Committee will be meeting in October.

### 11. Town Manager's Report

Marian Anderson said the American Legion had submitted a list names be added to the memorial wall;

Doug Fowler said he would be honored to seek the price for the additions.

Anderson said Clara Wentworth, DAR member, had brought in photos and asked for permission to put a small plaque by the tree that they had planted in honor of all veterans. Wentworth will research through the DAR where the plaque in the selectmen's office should be placed, possibly on the common. Kathy Martin-Savage moved to approve the placement of a small plaque by the tree behind the memorial. Vote 5-0-0.

Anderson said closing documents had been received for the pending conveyance between the Town and Central Maine Power for a new substation. The closing will be within the next month or so. Construction is tentatively scheduled for 2019.

The Budget Committee has met; the chairman is William Laliberte, Vice Chairman is Zachary Gray and the Clerk is Fred Quivey. Meetings will be held on the second Wednesday of the month at 6 p.m.

The EMS will be sending out fund-raising letters in order to buy a utility vehicle so that the department can respond when both ambulances are on calls.

Anderson said Wiscasset was the subject of an article in a recent issue of the AARP magazine.



### 2018 Application for Special Amusement Permit

### **Provisions:**

Wiscasset Speedway is located on 274 West Alna Road and has been home to local short track racing for 48 years. The facility sits on 35 acres of rural, gently rolling land with much of the back 10 +/- acres (previously unusable) now being made accessible with trees being cut/trimmed and grounds being mowed. The race track is 3/8 mile paved oval with high banked turns of eight to twelve degree banking, making Wiscasset Speedway Maine's biggest and fastest track.

With 25 racing events scheduled from April to October, Wiscasset Speedway had a successful 2017 season and we are excited to prepare Wiscasset Speedway's 49th year.

Traditional Saturday night racing will remain the primary focus with a proposed 2018 race schedule from April thru October. Pit Gate shall open at 2pm, practice from 3pm – 5pm, Main Gate to open at 4pm with a racing start time of 6pm as this schedule continues to be most popular race fans. While our focus is to primarily host Saturday night racing events as 3 to 3 ½ hour shows, we have learned unforeseen circumstances – ie numerous race cautions and/or rain delays prolong the race event beyond the current permitted end time of 10:00pm and we respectfully request to extend this particular end time when ever the need arises. Additionally, we shall once again host the very popular weekend long events, The Coastal 200, on Memorial Weekend and The Boss Hogg 150 in July or August.

Various interest groups continue to inquire about the use of our facility, as we consider the Speedway a year-around outdoor venue for family-focused events (in addition and not limited to stock car racing). Activities such as go-carting, truck pulls and monster truck shows appear to be very real events with concerts, swap-meets/flea markets, and movie nights being possibilities.

As we continue exploring opportunities with various venues, we respectfully request flexibility with days/hours of operation as we navigate and negotiate bringing potential events to benefit the entire area. Please be assured, our desire to be good neighbors and respected community member shall keep us mindful of operating with reason and common sense.

Both Main Grandstand and Pit Area are monitored gate entrances. The mechanism for crowd control for the Main Grandstands is to have tickets available for sale equal to maximum seating capacity, currently at 5,000 people. Maximum seating capacity is determined upon annual review and inspection of the State Fire Marshal's Office prior to opening day.

Pit Area admission requires registration of race car and the signature of every individual in addition to fees. This combined with having 115 Pads available for race cars provides for monitoring of maximum capacity.

In keeping with our goal of making this venue affordable for the entire family – General admission is \$5.00 per person and Pit Area admission is \$20.00 per person. These prices are extremely well received and remain unchanged for 2018.

### Water Supply:

Water supply source are two interconnected private wells located on the property. To the buildings that require water for drinking, cooking, washing and flushing of toilets, water is delivered under pressure exceeding normal operating pressures (20 lb per sq in minimum) to all fixtures at a rate of least 30 gallons person per day.

State Licensing from State Health Inspector requires water tests to be complete prior to opening day. Water tests were completed and found acceptable by State Health Inspector in the spring of 2017 prior to granting license of operation. Annual water testing is standard protocol per annual state licensing requirement and new enforcement policies mandated by the Governor. Next scheduled water test to be complete prior to opening in spring 2018.

### Bathrooms:

Main grandstand bathrooms are a separate building of 2x4 wood frame constructions - half dedicated to men and half dedicated to women. Men's room includes 3 urinals and 3 individual stalls with toilets (1 being handicap accessible) and 3 hand sinks for washing. Women's room includes 6 individual stalls with toilets (1 being handicap accessible) and three hand sinks for washing. Bathrooms shall be cleaned and serviced on a weekly basis and shall be monitored for cleanliness and re-stocking during race day by Wiscasset Speedway. In 2014 a new septic was installed in the area behind turn 4 grandstand.

Twelve portable toilets (2 being handicap accessible) are strategically placed through out the Pit Area and shall be cleaned and serviced on a weekly basis. During race day, portable toilets shall be monitored for cleanliness and re-stocking by Wiscasset Speedway. We are able to move portable toilets to further add to the main grand stand area facilities should it ever be necessary.

### Food Service:

Food concessions stands are located in the main grandstand area and in the Pit area. Both buildings were completely remodeled and updated under the recommendations, guidance of State Health Inspector's office with licensing issued upon completion and final inspection. A third concession stand located under the grandstand building features prepared items such as hotdogs, pizza, sandwiches, popcorn, chips & candy bars. All concession stands will be operated by Wiscasset Speedway and Serve-Safe Food Protection Manager Certification continues to be obtained by various concession staff personnel as well as Richard & Vanessa Jordan.

### Trash:

One 50 gallon trash container per 100 people to be provided through out the entire facility and monitored by Wiscasset Speedway. We continue to offer additional disposal services in the Pit area for race tires and race car debris as part of our desire to reduce future environmental impact. Final clean up of main grandstand, pit area and parking area as well as disposal of all trash will be complete within 24 hours.

### Parking Areas/Roads/Lighting:

Parking areas and pedestrian areas shall be lit with street lamps turned on as darkness descends and turned off upon facility closing all gates at the end of race day event.

All roads are at least 12 feet allowing for one way traffic. Parking area allows for 100 cars per acre with historically neighboring properties offering overflow parking.

### Medical:

At least four (4) State of Maine licensed Paramedics/EMT's provided medical coverage at each race day event. Wiscasset Ambulance Service provided weekly coverage and they have been notified of our plans to race in 2018.

### Fire:

Alna Fire Department & Waldoboro Fire Association provided a two person teams for each race day event in 2017. Teams were paid as invoiced. These departments and Wiscasset Fire have been notified of our plans to race in 2018 with the plan of dividing the race events to reduce the "load" of 25 weeks for one department.

### Safety:

Wiscasset Police Department provided security with two person teams at each race day event. Teams were paid as invoiced by Wiscasset Police Department and have been notified of our plans to race in 2018.

Wiscasset Speedway will not be selling alcohol and prohibits alcohol from all areas.

State of Maine Fire Marshal's Office Annual Inspection – schedule to inspect 3 to 4 weeks prior to opening day.

DHHS -Health Inspector - schedule to inspect 3 to 4 weeks prior to opening day - includes water testing.

### Noise:

Our policy continues to require race cars to have mufflers installed in effort to adhere to quieter standards.

Dalton asked approval to place the sculpture on the Recreation pier. He said the Waterfront Committee had approved the placing of the sculpture, which will be insulated pipe covered in a white, weatherproof pvc jacket spelling out the word "Hesper" and terminating in a public drinking fountain, tying into QT's water line. He has received grant funding for the project. Susan Blagden said the sculpture would need a certificate of appropriateness from the Historic Preservation Commission.

Selectman Rines stated he was in favor of approving the application tonight. Judy Colby moved to have Mr. Dalton get in touch with Ben Averill regarding the Historic Preservation Commission. Vote 3-1-0 (Rines opposed).



### TOWN CLOCK

The town clock, pictured on the cover, was presented to the Town of Wiscasset by Captain William Henry Clark in 1907. Captain Clark was born in Wiscasset and was a life long resident. The clock is an E. Howard "roundtop" circa 1900, with time and strike functions and was manufactured in Boston, Massachusetts. The clock was installed in the tower of the Methodist Church which is now the American Legion Hall. The 1993 restoration of the clock was performed by the Balzar family of Freeport, Maine. Properly maintained the clock will provide for hundreds of years of accurate timekeeping.

# Report from the Board of Selectmen

### Town Engineer's Report

To the Selectmen and the Citizens of Wiscasset:


During 1993 the Town of Wiscasset undertook a multitude of construction projects and began the design process of several projects for possible construction in 1994. The following is a partial list of 1993's engineering projects and their current status.

\* Article 31 of the March Town Meeting approved funds for the repair of the town clock. The clock, which was presented to the town in 1907 by Captain William Henry Clark, had not been in good working order for several years and was in need of restoration. The Balzer Family of Freeport was contracted with to perform the restoration. This work began with the removal of the clock from the tower. After disassembly each piece of the clock was carried down from the tower for transport to the Balzer's workshop. Assistance with the removal and later the reinstallation of the hands from the four clock faces was provided by the Wiscasset Fire Department. Upon completion of the restoration work the clock was reassembled for display in the hearing room of the municipal building. After this display the clock was again disassembled and then reassembled in the tower. Routine maintenance and regulation of the clock is now performed by the town engineer and Peter Rines. The restoration costs for this project totaled \$18,507.20.

- \* Construction of the softball field at the recreation center site continued in 1993. The field was covered with loam and seeded to establish a good turf growth. The backstop, foul line and outfield fencing was installed by Aroostock Fence Company of Lewiston, Maine. Their bid of \$11,995.90 was the lowest of the three bids received for the project. The final construction phase including ballfield lighting and the parking area will be completed in 1994 if funding is approved at town meeting.
- \* As a safety project at the Wiscasset Municipal Airport, a tree clearing/topping project was performed by Lucas Tree Company at the southern end of the runway.





