Re:

Wawenock LLC et al. v. Maine DOT

In its First Amended Complaint, Plaintiffs, three private landowners, made several allegations related to the Town that if accepted by the Court as true could affect the Town's rights and interests in the future. These statements include, but are not limited to, the following:

- Wiscasset Village in Wiscasset, including its downtown Main Street/Route I where Plaintiffs' Properties are located, is listed as historic in the National Registry of Historic Places.
- When the State nominated Wiscasset Village to the National Registry, it described the Village as "an authentic late 18th and 19th century sea and river port... [and] its buildings . . . remain, as a whole, intact and are a type of field museum that should be preserved."
- Wiscasset Village, including Main Street/Route 1, Middle and Water Streets where Plaintiffs' Properties are located, is also designated by Town Ordinance as a municipal Historic District, as to which the Town's Zoning Ordinance's historic preservation provisions apply.
- In September 2016, upon learning of MDOT's post-Vote Project changes, voters objected, and a Selectman observed that he felt "hoodwinked" by MDOT.
- In August, and again in September, 2016, MDOT proposed that the Selectmen sign alternative versions of a contract committing the Town to pay for certain Project construction and maintenance costs, without a Town vote.
- Although the Selectmen did not approve either MDOT's first proposed contract, or its revised proposed contract, they were persuaded by MDOT to "acknowledge" MDOT's "letter of its intent" that the Town pay certain Project costs.

Some of these statements are incorrect and other statements can be misleading. The reason why it is important that the Town involve itself in the litigation is the concept of Res Judicata, Latin for "the matter [already] judged", which says that if this Court in this litigation makes an adjudication on an issue that is adverse to the Town, then that issue binds the Town in all future cases and cannot be further disputed or even pursued by the Town in a later matter. Res Judicata only relates to findings on the merits of this case.

Current Status

At this time, the Court has granted Judgment on the Pleadings in favor of MDOT as a matter of law that does not relate to issues that affect the Town. Because the Motion for Judgment on the Pleadings did not address issues that affect the Town, the Town, on our recommendation, did not file a brief with the Trial Court related to the Motion, or file a brief with the Law Court when the matter was appealed.

For your information, attached is a Pleadings Index of all documents filed in this matter. Items filed on behalf of the Town are highlighted in yellow. Our strategy throughout has been to expend as little effort as possible while still monitoring the litigation so that if an issue that affects the rights and interests of the Town is raised, then the Town would be aware and could address the issue with the Court. To this end, we have filed only the minimum documents necessary and, as the issues related to the Town are yet to be addressed in the litigation, have otherwise monitored the litigation.

Going Forward

Given that the issues before the Law Court do not relate to the interests of the Town, it would be reasonable for the Town to not participate in the oral argument scheduled for Tuesday, May 15th. If that is the Town's decision, we would send a brief letter to the Clerk setting forth the Town's intent.

If the Law Court denies the appeal, then that should end this litigation and the matter will be fully resolved. If the Law Court grants the appeal or otherwise remands the matter back to the Trial Court, then the Town would need to participate in the lawsuit as a Party-in-Interest as required by the Rules of Civil Procedure. I would otherwise recommend that the Town monitor this litigation as the Town is intricately involved in the issues and some of the issues affect the Town's rights and interests and failure to address an issue with the Court now could result in Res Judicata, the matter being decided against the Town for all time in future lawsuits.
